



Terms and Conditions «Hotel Cinema 8»



1. Guaranteed room

A reservation is valid without any warranty till 4 p.m. on the day of arrival. With a room guarantee your reservation will be held upright for an arrival after 4 p.m. on the day of arrival.

As a guarantee for a room apply the following items:

- Credit card (Visa, American Express, MasterCard)
- Advance e.g. by bank transfer or postal order



2. No show

In case of a short-term cancellation after the cancellation deadline (see point 3) the first night of your reservation will be charged.



3. Cancellation policy

3.1 Bookings made directly with «Hotel Cinema 8» can only be cancelled in writing by e-mail to hotel@cinema8.ch



3.2 Cancellation policy for individual reservations

Cancellations till 4 p.m. one day before arrival: free of charge

Cancellations after 4 p.m. one day before arrival: the first night of the reservation will be charged.



3.3 Cancellation policy for group reservations (more than 10 people)

Cancellation up to 30 days before arrival: free of charge

Cancellation up to 14 days before arrival: 50% of the total amount will be charged

Cancellation up to 7 days before arrival: 80% of the total amount will be charged

Cancellation within 7 days prior to arrival: 100% of the total amount will be charged

20% of the people of a confirmed group reservation can be canceled up to 24 hours prior to arrival. If more than 20% of the people are canceled or if there is a complete cancellation the above cancellation conditions apply.



4. Registration form

For confirmation that a person stayed in our hotel, every new arriving guest is required to fill out a registration form with correct data and signature.



5. Bookings by tour operator

If the booking was made by a tour operator his terms and conditions will apply.



6. Prices for children

Child's bed is available on request only in specially equipped rooms. Children up to 5 years of age can stay for free in the parent's room. From 6 years on an extra amount of CHF 20.00 will be charged. From 16 years on the regular double usage amount is charged.



7. Payment

The price lists are per area of the company Cinema 8 individually, prices are subject to change without notice. All prices are in Swiss Francs, net, including service and VAT. For the conversion CHF to EUR our own defined conversion rate will apply. Prices apply if they are confirmed in writing by the Cinema 8 management.



8. Liability / due diligence

The hotel room has to be used by the guest with utmost care. For arising property damage the accountable guest or company has to pay. Missing furniture and / or furnishings are invoiced to the accountable guest or company. Cooking or preparing food in the hotel room is prohibited. The hotel declines any liability for theft, etc. also regarding third-party services.





9. Smoking / Open fire

Cinema 8 is smoke-free and prohibits any kind of open fire such as candles, incenses and suchlike. Damages and follow-up costs arising from infringement are invoiced to the accountable guest or company.

10. Pets

Pets are not allowed in the Cinema 8. Damages and follow-up costs arising from infringement are invoiced to the accountable guest or company.

11. Further provisions

Please note, that additional terms and booking conditions may apply. Further details are available on your booking confirmation or can be received by contacting the Cinema 8 reception.

12. Room card

On arrival the room card is handed over to the guest. The guest is obliged to bring back the card to the reception by check out. Should this not be the case, the guest has to pay a fee of CHF 25.00 per missing card.

13. Noise emissions

Out of consideration for other guests and neighbours noise emissions from 10 p.m. till 6 a.m. are forbidden.

14. Parking

Free parking is provided around the Cinema 8 complex. The parking can't be reserved.

15. First Celtic Lounge

Guests must be at least 22 years to access our First Celtic Lounge.

16. Theme room

Our theme rooms are bookable and obtainable for all guests over 18 years.

17. Sending bills

Invoices are only sent to companies with a current cost transfer.

18. Jurisdiction

Solely Swiss law applies for all signed contracts in form of bookings with the Hotel Cinema 8. Place of jurisdiction is Schöffland.
